Dear Senator:

*"Dishonest scales are an abomination to the Lord, but a just weight is His delight."* - Prov. 11:14

*"Every plant which my heavenly Father has not planted will be uprooted...and if the blind leads the blind, both will fall into a ditch."* - Matt. 15:13-14

This email is being sent to Republican Senators and Representatives (as well as some Democrat leaders). I am writing you this urgent letter for two reasons:

1. To entreat you in the strongest terms possible to do all in your power and use all of your influence to object to the presidential election on January 6<sup>th</sup>, and subsequently investigate all allegations of election fraud and malfeasance to the fullest terms.

The admonishment of Edmund Burke that "The only thing necessary for the triumph of evil is for good men to do nothing" is perfectly fitting for this moment because that is exactly what is occurring by many leaders from both parties who are allowing this election to be stolen right in front of the nation's eyes without any objections.

To steal a presidential election is to steal a country. The total spectrum of lawlessness and fraud that occurred in this election is tantamount to a Marxist-style takeover of our government and resembles events that happen in banana republics. Trying to somehow pretend that this election was a legitimate one, met all legal and honest standards, and that Joe Biden received 80 million votes in a purely organic fashion without any illegalities or irregularities is, in effect, to mock both God and man—since it is the tens of millions of Americans who know better, and it is the Almighty who knows all, and will *"catch the crafty in their craftiness."* - Job 5:12

Senate and House Republicans should understand that the only real way to keep the Senate or gain the House is to first keep the country. If the election fraud that took place is not exposed and overturned, there will be no House or Senate worth having because these will mean little to nothing if the very leaders that we have elected fail us in something so fundamental as ensuring election integrity. And furthermore, your own relevance in the future will drop drastically if you are absent from the battle in the present. This is happening on your watch, and the reason that we are dealing with something this threatening to our republic now is because of the persistent failure to confront the long train of abuses against our nation and lawful order by the forces within the media, the Democratic Party, and other agencies.

Those who claim that substantial voter fraud does not exist do not do so based on actual, thorough investigation, but rather on hearsay and using the tactics of double speak, misdirection, half-truths, isolating facts from their contexts, and manipulated assessments. This whole campaign of "insufficient evidence of voter fraud" is firstly an attempt to overwhelm the country with a false narrative in order to intimidate and obstruct any rightful action on the part of those who would normally question such rank

illegitimacy. Secondly, this becomes a pretense that allows weak leaders from every branch of government to evade their lawful and constitutional responsibility, which ultimately leads to a dereliction of duty on the part of those who would normally be expected to step up - if they were not so daunted by the task at hand. For silence, in this case, is consent, and denial is even worse.

The individuals claiming that voter fraud did not occur or has been debunked clearly seem to have an agenda of not seeing what they don't want to see. Have any of them consulted with or been briefed by the Trump legal team (and especially Rudy Giuliani), interviewed the affiants, encouraged a comprehensive investigation at a state or national level, or thoroughly read and evaluated the Navarro Report (which is the broadest report to date, and should be read.) The answer is self-evident - those who want to get to the truth would vigorously seek the truth out by all means, rather than finding reasons to avoid all the straightforward evidence. As just one example, no court at the state or federal level has actually conducted a functional trial, but rather has dismissed cases purely on procedural loopholes instead of on factual merit.

What is desperately needed in these election investigations, and what has thus far been entirely missing, is for one legislative body to investigate the entire sweep, survey, and summary of the massive attempt to undermine, interfere with, defraud, and steal the 2020 election. Every aspect of this attempt needs to be deeply and comprehensively evaluated and viewed in its whole context, rather than in its separate elements. Although each element in and of itself would be enough to restore the election to its proper standing, all the elements combined make it an impossibility that this election was legitimate.

This fragmented manner that has thus far been employed has no possible way of effecting true justice. Not only does this ineffectual approach avoid the kind of galvanizing, critical action that is needed, but it also perpetuates a dysfunctional method to getting to the core of what happened in the presidential election. Furthermore, this allows for a passing of responsibility of protecting our nation and constitution onto some other entity, which may or may not take on the cause. Essentially, no single governing force has taken on this election crisis in its totality - no one has reviewed, unified, and bridged all aspects of it into an all-embracing, thematic structure on a national level that would then be investigated in one concerted effort.

The direct result of this is the potential, unbelievable travesty that the greatest crime in American-political history is being unaddressed in full terms, and is being suppressed and allowed to stand in abject contempt of our nation. The idea that a U.S. Senator or Representative would somehow not make it his first and top priority to fight for the presidency and the country is very deeply disturbing and sickening. This is ground zero for you as an individual Senator and for Congress as a whole.

In reality, the presidency of Donald Trump was treacherously undermined from day one - and the events of this election represent the last attempts to steal his total presidency. The truth is this election was fatally flawed and ill-fated from the moment that election laws were illegally allowed to be changed in multiple key states to ensure that millions of ballots could be indiscriminately mailed out without guaranteeing the proper chain of custody throughout the process.

To allow this comprehensive fraud to stand is to court disaster, remove the blessing of God, and to essentially invite the same curse of illegitimacy on our land that has destroyed many nations. Because of the sheer breaking of spiritual law that is represented here, there is zero chance that any good can come from this endeavor to Joe Biden, the Democratic Party, the media, the complicit Republicans, or anyone else involved. On the contrary, unless those involved disavow what has taken place and make a clean break from it, the negative impact on real life is potentially devastating, as one reaps exactly what he sows.

On a broader scale, it seems as though certain influential leaders in the Democratic Party, the media, and

elsewhere have created a new normal that centers on a culture that allows for lying, cheating, mob rule, and violence. In this, a warped philosophy of “by any means necessary” has replaced honest Judeo-Christian values, which use to be proudly embraced by the party. And it is this usurpation of Judeo-Christian values that has perverted the entire sense and pursuit of justice. This explains why, instead of competing against Donald Trump for the presidency by developing a stronger America First platform than he did, they felt at liberty to use the leftist tactics that they did. But even those individuals (from either party) who oppose President Trump should know that cheating in an election can only backfire and have the exact opposite effect of what they desire.

What I hear the most from Republican voters is the frustration that essentially “Democrats are ruthless, while Republicans are spineless”. As an independent—who truly desires that we have two solid, strong, patriotic parties—it seems to me that some democrats are more emboldened to do the wrong thing than republicans are in doing the right thing, and that republicans are more concerned with not upsetting the mob, than they are with doing the right thing for this country. And did the brave World War II generation of Americans defeat fascism, nazism, and imperialism in Europe and Southeast Asia only to have a future generation of American leaders surrender our “freedom” and righteousness at home by fearing agitators and rogue mobs who have been allowed to think they are more powerful than they really are?

Both history and the Scriptures teach us that the surest way to maintain peace in a nation is through righteousness and truth, and putting down unrightful rioting against our society... while the surest way to undo civil order is to embitter the law abiding people by allowing corruption, chaos, and unrighteousness to go unchecked.

So much evil, discord, division, and lawlessness have been sown into our country over the last few years that the sheer stress of it all has good, everyday patriotic Americans and our nation very close to the breaking point. We have allowed nefarious actors from multiple sectors to abuse the sacred trust of the people by eviscerating our constitution, way of life, and now our entire concept of truth, justice, and fairness. If mature leaders from both parties do not immediately do what is right, things could spiral out of everyone's control very quickly - in which case everyone loses.

All of the confusion, timidity, inaction, and denial of election malfeasance on the part of any American political leader would quickly disappear if only these individuals would simply determine, above all other considerations, to do God's will on this matter by asking for the wisdom and strength to do the right thing on January 6<sup>th</sup>. The last thing that any leader wants on his consciousness or in his legacy is to fail God and the country through cowardice or cravenness. Therefore, the only thing to do is to reject the false results of the election, or otherwise be very clear in your heart and mind that those false results did in fact not occur.
